## NOTIFICATION

S.O. 1848(E).—In exercise of the powers conferred by clause (d) of sub-section (1) of section 4 and sub-section (4) of Section 4 of the New Delhi Municipal Council Act, 1994 (44 of 1994), the Central Government hereby nominates Shri Karan Singh Tanwar as Member and Vice-Chairperson of the New Delhi Municipal Council and for that purpose makes the following further amendment in the notification of the Government of India in the Ministry of Home Affairs number S.O. 2239(E) dated the 5th September, 2014 with effect from the date of publication of this notification in the Official Gazette, namely:—

In the said notification

(1) In sub-paragraph (d) of paragraph 1 under the heading “Under-clause (d) of sub-section (1) of section 4, for item number (i) and the entry relating thereto, the following item number and entry shall be substituted, namely:—

“(i) Shri Karan Singh Tanwar”

(2) In sub-paragraph (f) of paragraph 1 under the heading “Under sub-section (4) of section 4”, the following entry shall be substituted, namely:—

“Shri Karan Singh Tanwar - Vice-Chairperson”
