**Sub : Constitution of Empowered Committee**

1. In preparation for the upcoming G-20 Summit Meetings – 2023, NDMC is expected to take up various activities/projects related to infrastructure creation, maintenance and their aesthetic upkeep. This also involves media and social outreach, organization of large-scale events and coordination with other executing agencies. To ensure time bound execution and completion of these activities, it has been decided to constitute Empowered Committee(s) as below.
2. These committee(s) will be responsible for
  - a. Ensuring timely completion of identified works, take decision on bottlenecks, if any and monitor their progress regularly.
  - b. Any inter departmental or inter agency coordination, both within and outside NDMC, shall be ensured by them.
  - c. The committee(s) shall exercise such financial power(s) as indicated against each, based on advice of Associated Finance and recommendation of concerned HoD.
  - d. The Committee(s) may meet frequently but at least once every week.
  - e. The Committee(s) will report to Chairman periodically and at least once every week.
  - f. The Committee(s) shall be empowered to seek information and issue directions to any department/official of NDMC to achieve its objective.
3. The constitution of each committee shall be as follows:

**A. Empowered Committee on infrastructure Up-gradation (ECIU)**

**Financial Power:** To accord AIP, AA&ES and approval to subsequent award for work/supply/activity, of all kinds, beyond delegated powers of HOD and up to Rs. 2.5 Crores (Rs Two and Half crore)

On its withdrawal, the works undertaken shall be continued/completed under standard delegation of financial powers dated. 04.10.2022.
