3. a. I undertake no to use any tent made of synthetic or any other informable material.

b. That I shall provide sufficient quantity of fire extinguishers, minimum 4 fire extinguishers, out of which 2 containing Co.2 and two foam type.

c. That I shall provide minimum 2 gates for easy entrance and exit of the visitors.

d. That the kitchen tent would be quite independent and shall be kept at a distance of more than 15 feet from the main tent of the function.

e. That I undertake to inform the local fire office about the function at least 12 hrs. before the starting of the function.

f. That I shall not use halogen lamps anywhere inside the pandal.

g. That no part of the electrical Circuit in the structure of the pandal shall be within 15 cms. Of any decorative material from the roof.

h. That the wiring work for temp. elect. connection shall be got done from the Licensed electrical contractor only.

4. That in case of any violation, NDMC shall be at liberty to forfeit security deposit towards temp. elect. connection without prejudice to their right of disconnection of electric supply and criminal prosecution as per the provisions of Punjab
