3. Brief History of the Project

Since the last few years the existing infrastructure and facility at Charak Palika Hospital (CPH) have been proving to be quite inadequate to cater to the aspirations of public that visit the CPH for treatment. As such there is an urgent need for upgradation of existing structure as well as introduction of latest facilities which are required now- a-days in the CPH. Keeping this in consideration a proposal for upgradation was mooted. Due to non-viability of existing building for vertical expansion and inadequacy of vacant land for required horizontal expansion, and the up-gradation, and inadequate adjoining area to existing building to support the proposed upgradation of CPH, construction of extension of CPH at Moti Bagh at the place of existing Veterinary Hospital after merging the existing plot of the school building has been proposed /planned. Accordingly these existing structures are required to be demolished.

4. Detailed proposal on the Project

A composite estimate for disposal of the existing building of Veterinary Hospital, residential complex and School Building has been prepared. This estimate has been prepared for demolition of existing structure to clear the space for construction of extension of CPH at Moti Bagh as the existing CPH is not capable to cope up with the patient treatment and there is no scope for up-gradation of the existing location. Therefore NDMC planned to construct new hospital in place of existing building of Veterinary Hospital, residential complex and School Building.

5. Financial implications of the proposed Project

Rs. 96,17,627.00 is to be written off on account of demolition of the existing building coming in the alignment of the proposed project with a sum of Rs. 17,56,066.00 as reserve price for demolished material.

The work of dismantling and disposal of serviceable and unserviceable material will be clubbed with the main tender for construction of Hospital Building after change

of land use by DDA.

7. Final Comments of the Finance Department on the subject with diary No. & Date.

FD has seen the case earlier at Page-12/N wherein department has submitted the reserve price of Rs. 24,65,900/-. While submitting the case for approval, Chairperson has recorded minutes at Page-22/N that "No action till the plot is amalgamated". Department has further stated at Page-23/N that L&DO has amalgamated the plots of Veterinary Hospital and School building vide OM dated 09.03.2015. Now the proposal has again been received in the Finance Department for approval with modified reserve price of Rs. 17,56,066/- duly checked by planning at Page-25/N. The Reserve price has now been worked out to Rs. 17,56,066/- at Flag A. The reasons for reducing Reserve price from Rs. 24,65,900/-to Rs. 17,56,066/- has been stated that the salvage value of the material has been reduced due to increase of the life of the material (depreciation value) and increase in the cost of dismantling due to increase in the rates of the labour.

In view of clarification brought on record w.r.t. observations of the FD, Page-26/N including certification that Survey Report has been prepared as per Section 6.8 of CPWD Works Manual, department may process its Survey Report amounting to Rs. 17,56,066/- duly checked by the Planning at Page-26/N & recommended by CE(C-I), for obtaining approval of the competent authority.
