1. Name of the Subject/Project:

Subject:- Providing and fixing MS railing on Central Verge at S.P. Marg and Mother Teresa Crescent including construction of Central Verge by providing precast C.C. kerb stone at Mother Teresa Crescent.

2. Name of the Department:

Civil Engineering Department, Roads-IV Division.

3. Brief History of the Project:

- (i) Dy. Commissioner of Police Security (PM) : New Delhi vide letter No. 23475/F/Sec(PM), dated 06.03.14 addressed to Secretary, NDMC regarding providing MS railing/Iron grill on entire stretch of central verge from Mother Teresa Crescent (Teen Murti to 11 Murti T Point Mother Teresa Crescent) upto Dhaula Kuan on S.P. Marg to avoid any accident/intrusion into the VIP motorcade, during road journey crescent for AFS Palam by the Hon'ble Prime Minister of Indian and other VVIPs.
- (ii) Accordingly, the layout plan of S.P. Marg and Mother Teresa Crescent was sent to The Chief Architect of NDMC who has submitted a design of proposed M.S. railing to be fixed.
- (iii) This design has been approved by the Chairman at P-4/N.
- (iv) The project being of more than Rs.50 lacs value, the Project Report has also been prepared duly signed by the Members of the Standing Committee in consonance with the Standing Order No.07 dt.02.09.03.
- (v) Accordingly, the cost of the work has been worked out and P.E. amounting to Rs.2,44,86,000/- duly checked by the planning division and concurrence by the finance department is here by submitted for obtain the Administrative approval and expenditure section

4. Detailed proposal on the subject/project

Proposed MS pipe railing at S.P. Marg includes following Scope of work:-

- (i) 40x40x3 mm MS hollow pipe joined with each other with horizontal and vertical member and vertical post of 75x75x5mm Hollow pipe having the height of 800 mm.
- (ii) Total height of central verge will be 1.20M (i/c height of kerb stone (0.40M) + MS railing (0.80M).

5. Financial Implication of the proposal subject/Project.

The Financial implication is the scheme works out to Rs. 2,44,86,000/-.

6. Implementation schedule with time limits for such stage including internal processing.

The schedule period of completion is Six Months after award of work.

- (ii) Modified drawing of MS railing is acceptable and will cater the safety requirement in view of letter of DCP(Traffic).
- (iii) CE(C-I) may sign the abstract of estimate.
