#### 1. Name of the subject/project

Sub: Improvement to existing footpath at Netaji Nagar, Nauroji Nagar and Sarojini Nagar Area (Phase-I)

#### 2. Name of the Department

Civil Engineering Department, Road Division-III

#### 3. Brief history of the subject/project

- (a) The precast RCC footpaths of the roads in Netaji Nagar, Nauroji Nagar & Sarojini Nagar were constructed around 1990. The conditions of these footpaths has deteriorated due to wear & tear, cuttings by various utility providers and have outlived their life. So there is need to improve these footpaths. Accordingly, Preliminary Estimate for improvement of footpaths of roads in Netaji Nagar, Nauroji Nagar, Sarojini Nagar area was approved by the Council vide Agenda Item No.05(A-46) dated 17 Jun.'09 for Rs.4,22,58,400/-.
- (b) The tenders were invited for third time through e-tendering system with the date of opening as 13 May'10. In first & second call only one eligible tender was received & was therefore rejected by Competent Authority. The details of eligible financial bids received in third call are as follows:-

#### (2) Name of the Department : Electricity

#### (3) Brief History of the case :

NDMC has awarded the work of establishing various 33 & 66 KV Sub-stations at various locations to M/s PGCIL. The work at one of these Sub-stations namely; Sub-station 33 KV Connaught Place is on the verge of completion. To utilize the transformer capacity being installed there, some 11 KV feeders have been proposed to be emanated from this Sub-station.

An estimate of outgoing 11KV cables to various substations from 33KV substation Connaught Place, which is being constructed, has been prepared and submitted to Finance Deptt. for concurrence. Finance Deptt. in one of their observation have desired that the case may be sent to Advisor (Elect.)/Advisor (Power) for their comments to ascertain that the proposal of the Deptt. is technically sound. Accordingly the case was sent to Advisor (Elect.)./Advisor (Power). They have given some suggestions, which have been complied with and accordingly estimate has been framed.

#### (4) Detailed proposal on the Project :

- (a) 2 x 400 sq.mm 11 KV XLPE cable has been from 33 KV Sub-station Connaught Place to Sub-station Electric Lane (New) via proposed 33 KV Sub-station Handloom Complex.
- (b) 2 x 400 sq.mm 11 KV XLPE cable has been proposed from 33 KV Sub-station Connaught Place to existing Sub-station as inter-connector in S.S.G. Board.
- (c) LILO of existing cable from Sub-station C-II Tilak Marg to Sub-station Bharat Hotel { which was to be dismantled against estimate No. E-18/2008 issued to E.E.(C-I) } at 33 KV Sub-station Mandi House, Sub-station Kanchanjunga building and Sub-station Office block (World Trade Tower.

This arrangement has been made to strengthen the existing 11 KV Electric Substations as well as give relief to existing 33 KV Sub-stations.

#### ITEM NO. 04 (B-21)

(1) **Name of the work** : Construction of 11 KV Electric Switching-station near American Embassy School, Chanakya Puri, New Delhi.

#### (2) Name of the Department : Electricity

#### (3) Brief History of the case :

Keeping in view the growing load demand in NDMC area, Chairperson NDMC had written a letter dated 1-2-2001 to Minister of Urban Development. Govt. of India for allotment of 81 sites for establishing of E.S.S. at 220 KV, 66 KV, 33 KV & 11 KV voltage levels at various places in NDMC area. A large number of new buildings are coming up for diplomatic missions and international organizations, spurt in constructional activities upgradation of markets and government colonies, hospitals as well as enhancement of air conditioning load in the existing buildings in NDMC area.

A plot for establishing 11 KV Electric Switching-station near American Embassy School, Chanakya Puri, New Delhi has been allotted by L&DO. The drawing of the same has also been prepared by C.A., NDMC. This proposed Sub-station would conceptually be a local distribution Sub-station as well as a switching station.

The plot is strategically located in various Diplomatic Missions and institutions. Recently some new buildings like; Embassy of Palestine, Embassy of Tanzania, Vivekanand Kendra, Afro-Asian organization, Kathak Dance Kendra etc. have already been built. Some more buildings like; Embassy of Saudi Arabia, expansion of Thailand Embassy etc. are likely to come up soon. Presently there is no other Sub-station in the vicinity of these Institutions/Embassies to feed power supply to them. Beside this the other existing Sub-stations in Chanakyapuri like; Nehru Park, Bapu Dham, S.P.Marg are generally over loaded. These are to be given relief by shifting some feeders to this proposed Sub-station.

#### (4) Detailed proposal on the Project :

The sub-station shall have provision of 2x1000 KVA capacity with one no. H.T. Board having

9 nos. panels and following HT cables:-

- (a) 2 x 400 sq.mm 11 KV XLPE cable has been proposed from 33 KV Sub-station Sanjay Gandhi Camp as incomer.
- (b) 2 x 400 sq.mm 11 KV XLPE cable has been proposed from Switching-station Veeranwali .

The proposed oil type transformers shall be installed out of the transformers which would be spare after replacement/ augmentation of oil type transformer with dry type transformer. 50% cost of new transformer as indicative cost has been taken in this estimate on account of providing old dismantled transformer. The service cable for IEI of sub- station have been proposed from near by G.S. Pillar.

Establishment of 33KV ESS at Handloom Complex, Janpath Lane

#### 3. Brief history of the proposals-

The power demand surrounding Janpath lane and nearby area is increasing rapidly due to redevelopment of the area, increase in the demand of the existing consumer due to air-conditioning and computerization etc. The existing 33KV ESS in the area are loaded more than 80% their Capacity. Now at the Janpath lane the Handloom complex is being redeveloped and load of the new complex would be more than 4MVA. Presently load demand of the area is being fed through 11KV network therefore establishing of 33KV New S/S is essential.

#### 4. Detailed proposal on the Project-

Keeping in view the incoming load demand more than 4MVA for Handloom Complex and surrounding area; future load and to keep the system more flexible and reliable. Following are being proposed in the estimate.

1.	16/20MVA, 33/11KV Pr. Transformer	-	2No.
2.	33KV GIS 6-panel with its C&R Board	-	1No.
3.	33KV, 3CX400mm2 , Al conductor XLPE cable	-	5800M
4.	11KV, VCB 11-panel with its C&R Board	-	1No.

There shall be two independent feed each from 220/33KV HCM lane and 66/33KV ESS School Lane are proposed.

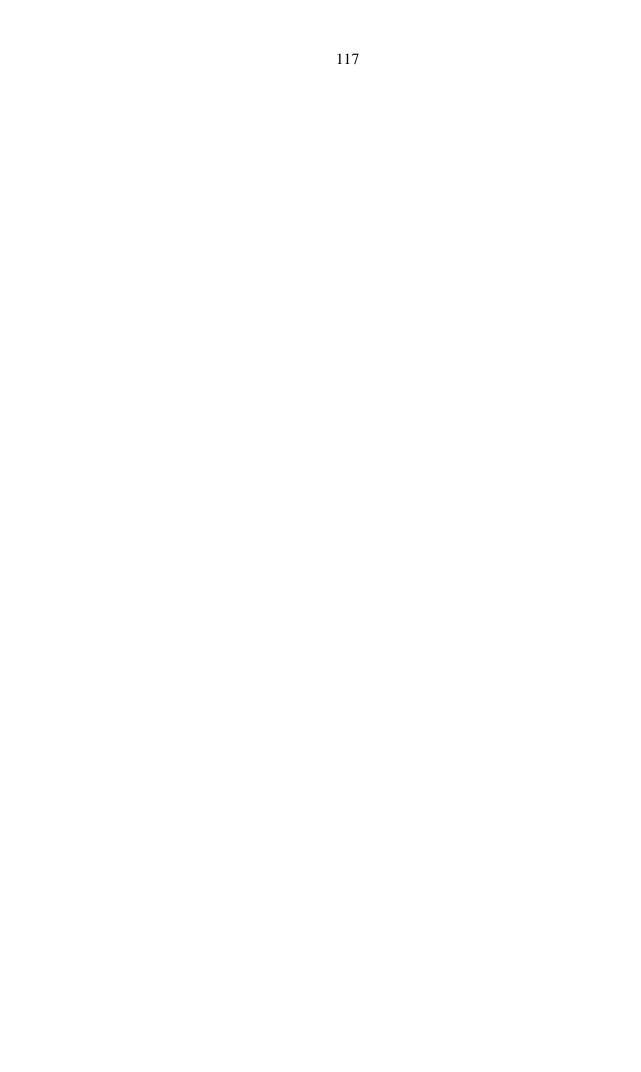




































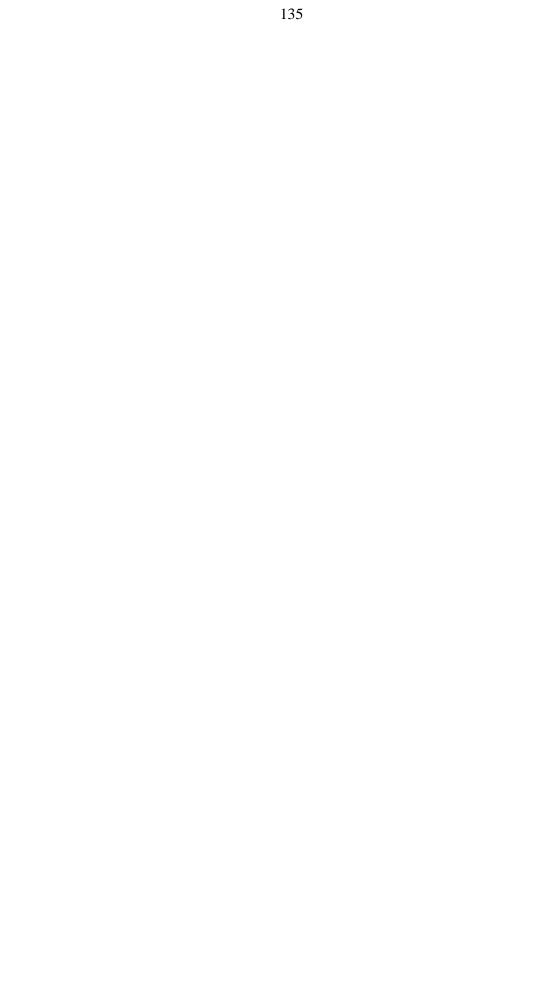

# 1. Name of the subject/Project :-

Extending the date for payment of property tax with rebates for those who pay the taxes under Bye-Law, 2009.

# 2. Name of the Department :-

Property Tax Department.

# 3. Brief History of the subject/project :-

The Council in its Resolution No.13(F-02) dated 15.01.2010 had resolved that all those who pay the property tax, for the year 2010-2011, under the Annual Rent Bye-Laws of 2009 will be entitled to a 10% rebate, at the time of payment of taxes, if the taxes are paid by 30.09.2010.

Property tax bills for the year 2010-2011 can be issued only after the objections received from the public, in response to a public notice, are disposed of and the assessment list has been authenticated. The assessment list for the year 2010-2011 has been authenticated on 18.10.2010 and the property tax bills for the year 2010-2011 can now be issued. Since the date for availing the rebate of 10% has already expired being 30.09.2010, unless the date is extended, the tax-payers would be deprived of the rebate, at the time of payment of the property tax. As the last date for payment of property tax with rebate is already over.

#### 4. Detailed proposal on the subject/project:-

Council had resolved that whosoever will pay the property tax upto 30.09.2010 would be entitled to a rebate of 10% and those who pay the tax between 1<sup>st</sup> October, 2010 to 31<sup>st</sup> December, 2010 would be entitled to a rebate of 5% instead of 10%. It is proposed that the date for payment of property tax. The 10% rebate for those who file the return under the Bye-Laws, 2009 and pay the taxes under the new Bye-Laws may be extended upto 31.12.2010. However, for the convenience of the tax-payers and to avoid rush, the due date for rebate may be fixed as under :-

Bills issued upto	Pay by date for 10% rebate
31.10.2010	30.11.2010
15.11.2010	15.12.2010
30.11.2010	31.12.2010

If the tax-payers has not received the bill or could not make the payment for valid reasons, the date can be extended upto 31.12.2010 by the Chairperson or the person authorized by him but in no case, the rebate of 10% would be available after 31.12.2010.

5. Financial implications of the proposes project/subject :-

There has been a delay in the issue of the bills and as such the date is being extended not beyond 31.12.2010. There is no financial implications, as only the date for payment of tax is being extended.

It was resolved that these facilities are available to their family members also on the same terms and conditions as are applicable to Group 'A' officers till the duration of their membership of the Council and subject to the contribution as applicable.
