Sir,

With reference to your application on the subject cited above, It is to inform you that Sanction of Net Metering for Solar Power plant 3 Kw on the roof top at Pump House No. 2, Bhagwan Dass Road ,New Delhi has been approved by the competent authority.

Sanction of Net Metering for Solar Power injecting to NDMC Grid is on the following conditions:-

1. There would be no Voltage fluctuation on account of integration of Solar Power in NDMC System.
2. There would be no introduction of harmonics in the system.
3. The supply system would remain stable with integration of Solar Power.
4. The Solar Project is installed confirming to DERC/CEA guidelines and meet all regulatory requirements. In case any disturbances are caused in the supply system due to poor workmanship/ quality in the solar power plant, NDMC shall not be held responsible.
5. Separate earthing has been taken in terms of DERC quid lines under Net Metering for renewable energy regulation 2014 please.
6. The sanction is based on the documents provided by the applicant. Any dispute regarding legal occupancy of the premises shall be settled by the applicant at his own end.
7. In case of electricity is to be used for a licensable trade N.O.C./License from the competent authority shall be obtained.
8. Sanction of electricity connection shall not confer any legal right for regularization of building/ land use and electricity supply shall be liable for disconnection of Meter/ Service line without notice from NDMC where the Govt. or the concerned competent Govt. Agency such as NDMC, DDA etc., conveys immediate action for sealing/ demolition/ vacation of the building/ land in order to discharge their statutory obligation.
