With reference to your application for the subject cited matter, it is to inform that the Net Metering for renewable energy source of Solar Power Plant 20 KWp capacity has been sanctioned by the Competent Authority at 23, Akbar Road, New Delhi under Domestic Category on the basis of requisite documents & fees deposited as under.

- Approved renewable generation capacity (peak) of Solar Power Plant 20 KWp.
- Reference of application fee of Rs. 500/- deposited vide challan No. 675198 dt. 18.3.2021.
- Reference of registration fee of Rs. 3000/- deposited vide challan No. 675570 dt. 23.3.2021

The sanction of renewable energy source of Solar System is on the following conditions.

- There would be no voltage fluctuation on account of integration of Solar Power in NDMC system.
- There would be no introduction of harmonics in the system.
- The supply system would remain stable with integration of Solar Power.
- That Solar Project is installed confirming to DERC/CEA guidelines and meet all regulatory requirements. In case any disturbance are caused in the supply system due to poor workmanship/quality in the Solar Power Plant, NDMC shall not be held responsible.
- The earthing result of Solar Plant should be within limit.

The installed Solar Power system is technically suitable for "Net Metering" in NDMC supply grid to Import and Export the power supply through the existing LT cable of size 95sqmm/3.5C as approved by the competent authority.


