

As per the directions of the Competent Authority, Health Department has prepared the list of applicants, who has applied under Section 331 /332/ 325 of the NDMC Act, 1994. The status of NOC's from various departments such as Chief Architect, EBR, Tax, Estate (I & II as the case may be), Delhi Fire Service (wherever required) has been included in the tabulated form.
