NDMC intends to select a Concessionaire for "Design, Development, Implementation, Operation and Maintenance of Wi-Fi, Smart LED Street Light, City Surveillance, Command and Control Centre in NDMC area in lieu of use of Street Light Poles for hosting Telecom Services and use of Right of Way (RoW) for Laying Optical Fiber for Telecom Services" which are described in the enclosed documents after referred to as "The Project".

NDMC, after evaluating the aforesaid invitation of RFP, accepted the proposals for the project "Request for Proposal for Selection of Concessionaire for Design, Development, Implementation, Operation and Maintenance of Wi-Fi, Smart LED Street Light, City Surveillance, Command and Control Centre in NDMC area in lieu of use of Street Light Poles for hosting Telecom Services and use of Right of Way (RoW) for Laying Optical Fiber for Telecom Services", submitted by the applicant/bidder. Following documents were received alongwith the offer.
 - (i) Technical bid submitted by the applicant/Concessionaire.
 - (ii) Financial Bid.

- E. In accordance with the requirement of the said proposal/bids submitted by the CONCESSIONAIRE, NDMC has agreed to grant the CONCESSION (as hereinafter defined) for the Concession Period of Fifteen years (one year implementation period + fourteen years post-implementation period). At the end of the concession period to transfer all the infrastructure developed by the Concessionaire during implementation, maintenance and operation period to NDMC, on the terms & conditions and covenants hereinafter set forth in the Agreement.
- F. Letter of Award No. _____ dated____ accepted by the Concessionaire.
- G. The CONCESSIONAIRE hereby accepts the CONCESSION granted and undertakes to implement the Project in terms of the CONTRACT.
