EXPRESSION OF INTEREST FOR ETP

NDMC (New Delhi Municipal Council) is a civic body responsible for maintenance for Roads, Water, Sewer and Electricity in its area. An EOI (Expression of Interest) is hereby invited from reputed manufacturer/ operators for ETP (Effluent Treatment Plant) for survey / installation (if required), along with O & M of existing ETPs in Connaught Place area. NDMC is interested to empanel at least 5 good agencies to operate and maintain the existing ETPs in Connaught Place area at the cost of user itself. The list of about 60 ETPs along with its location and existing capacity can be obtained from the office of EE(SM). The scope of work is as under:-

- Presently most of the individual eatery / restaurant is having independent ETP but the same is not being maintained properly.
- The bidder shall be responsible for re-designing / modification, if any, and successfully run the ETP for next 5 years at the cost of owner convened.
- All the DPCC norms and MSW Rule 2016 shall be applicable for treated water through ETP.
- If need be, 2 or 3 restaurant / eatery can be placed with common ETP for treatment of kitchen discharge provided owners agree to it.

Interested bidder having requisite experience for running of ETP for at least 3 years are invited to submit their EOI with necessary documents supporting with the qualification criteria and other credentials along with the proposed schemes / methodology with time to be taken.
