CIRCULAR

It has been directed that every SE of Engineering Wing shall adopt residential colonies with special focus on upkeep of maintenance standards as well as cleanliness under Swachh Bharat Mission.

They will conduct inspection on weekly basis continuously for two months and thereafter, fortnightly in subsequent months submit their reports to the concerned EE directly and copy of the same shall be endorsed to concerned SE and Chief Engineer of respective Engineering Wing and similarly, to Circle-In-Charge and MOH of Health Deptt. and DD and Dir.(Horticulture). A vigil eye on follow up shall also be maintained and any lapse noticed, shall be reported directly to concerned HOD.

Estate, New Delhi-110002 in hard copy and soft copy at e-mail address osdswachhbharat@gmail.com and psud@nic.in. Performa for inspection would remain the same as that circulated for general inspections.
