
- (i) Secretary, NDMC advised that Chief Architect have to frame a policy within three months with respect to the usage of Mezzanine Floor in respect of Connaught Place area so that uniform stand in respect of such restaurants who are using the Mezzanine Floor for the sitting purpose may be taken. Meanwhile, the restaurants approved for renewal/grant of the licence to submit an undertaking that whatsoever decision of NDMC with respect to the Mezzanine floor shall be taken complied with failing which the licence can be revoked/cancelled accordingly.
- (ii) Chief Architect point out that Health Licence Department did not share the details of sitting plan capacity of certain restaurants and in these cases firm view cannot be taken on such cases. Secretary directed that such details be shared with all the departments immediately. CMOs (HL) of each circle do the needful.
- (iii) Notices issued by the EBR Department and other departments due to violations should be shared with the Health Licensing Department time to time so that necessary action against the applicants for violating the terms and conditions as well as their undertakings at the time of applying the licence could be taken.
- (iv) The health licence in respect of Estate properties which have been approved for grant/renewal for three months on account of delay in renewal of licence deed by the Estate Department, the health licence will be extended for full term, in case the licence deed renewed by Estate Department.
- (v) The concerned Departments in respect of deferred cases would issue notices to the respective restaurants for meeting their requirements/violations and take a final decision in 03 months positively. The Committee would take a final view on these cases once their recommendations are received.


(vi) Secretary, NDMC has also emphasized that Enforcement Department should take regular action against vendors/dhabas/trolleys/restaurants etc. which are not having any valid health licence and creating insanitary conditions in public area.


