- viii) Check on agree.
- ix) Online application for allotment/ change of Municipal Accommodation under UWL registration opens.
- x) Fill up the all columns except prefilled.
- xi) Click on submit button.
- xii) Take print of submitted form.

4. The Procedure for allotment and change of municipal accommodation have been circulated by the Municipal Housing Department vide Office Order No. D-1508/JD(MH)/2016 dated 15-12-2016 and D-159/JD (MH)/2017 dated 09-02-2017.
