After due deliberations, it was decided that this list will be given to the Director (Enforcement) for requesting legal action under the provisions of the relevant section of the NDMC Act.
- (ii) Secretary also directed that all the pending cases received till 28th Feb., 2018 may be compiled with and put up before the next meeting of High Empowered Committee on 15th March, 2018 and all the departments may come up with clear cut recommendations and no further time would be given for deciding the cases.




