Subject:- Filling up the post of Chief Engineer (Civil) in the pay scale of Rs. 37,400-67000 Grade Pay Rs.8900/- (6<sup>th</sup> CPC)

The New Delhi Municipal Council proposes to fill up a post of Chief Engineer (Civil) on deputation basis. The pay scale, educational qualification, eligibility criteria etc. of the post as per the extant Recruitment Rules is as follows:-

A. Pay Scale

Rs. 37,400-67,000 + Grade Pay Rs. 8900 /- (6<sup>th</sup> CPC) (pre-revised)  
(Rs. 1,31,100-2,16,600 level 13A in revised pay matrix).

B. Eligibility

Officers under the Central/States Govts./UTs/Universities/Recognized Research Institutions/Public Sector Undertakings/Semi-Govt./Autonomous or Statutory Organizations:-

(a) (i) Holding analogous posts on regular basis; or

(ii) With 02 years regular service in posts in the Scale of Rs. 14300-18300 (5<sup>th</sup> CPC) (Rs.37400-67000+ Grade Pay Rs.8700) pre-revised) (Rs. 1,18,500-2,14,100 level 13 in revised pay matrix) or equivalent; or

(iii) With 07 years regular service in posts in the scale of Rs. 12000-16500 (6<sup>th</sup> CPC) (Rs.15600-39000+Grade Pay Rs.7600) (Rs. 78,800-2,09,200 level 12 in revised pay matrix); and.

(b) Possessing a degree in Civil Engineering from a recognized university or equivalent with 14 years experience in Civil Engineering works.

(The departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for a appointment by promotion).

[Period of deputation / contract including period of deputation contract in another Ex-Cadre post held immediately proceeding this appointment in the same or some other organization / department of the Central Government shall ordinary not exceed three years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of the receipt of the application].

C. Tenure:

2. For a period of three years extendable as per policy of the govt. in vogue. As per consolidated instructions on deputation issued by DoPT vide O.M. dated 17.06.2010, a person drawing salary in higher grade cannot be appointed on deputation basis in the lower post. There is no bar on consideration of an officer who is drawing salary in higher pay scale grant on account of non functional upgradation for appointment to a post having lower pay scale as salary in the deputation post is determined with respect to substantive post held by an officer in parent department .


However, his/her salary on deputation in such cases is to be fixed in terms of DoPT instructions issued vide O.M. dated 24.11.2017.

- iii. Latest vigilance/cadre clearance

4. The application alongwith the above said documents should reach this office latest by 15.01.2018. Applications not sent through proper channel and/or without the above said documents are liable to be rejected.

5. Officers who have already applied for deputation against the vacancy circular dated 02.01.2017 need not to apply again provided they are eligible in terms of eligibility criteria indicate above and their application have been forwarded through proper channel.


