SPECIAL CONDITIONS

- 3. The works executed by the Contractor shall at all times be open for inspection of Engineer in Charge or his authorized representative.
- The contractor will be fully responsible for the safe custody of the material right from the time of possession taken of the same from the NDMC's Engineers.
- No compensation for any damage caused to the works or materials by rain, flood or other natural calamities shall be paid to the contractor. The contractor shall have to bear the complete cost to repair/replace the damaged work/material.
- 6. Minor material such as nuts, bolts, washers, M.S. Hooks, thimbles, ferrules, clamp etc. require to complete the job will be provided by the contractor without any extra charges.
