- OTHER TERMS AND CONDITIONS: 1. EMD: EMD amount of Rs. 12,317/- in the form of demand draft/banker cheque drawn in f/o The Secretary, NDMC has to be deposited by the bidder along with quotation, failing which quotation shall be summarily rejected.
- 2. Procedure for submitting quotation: The bidder is required to submit the quotation in two cover systems. The envelopes should be super-scribed with quotation number, name of works and EMD/price bid. The envelope containing EMD shall be opened first. The second cover containing quotation shall be opened thereafter.
- 3. Rates: The rates shall be written in figure as well as in words.
- 4. Validity: The rates should hold good for 2 months from the date of opening of the quotation. The validity period quoted less than
- 5. Completion period: The works should be completed within 45 days which shall be reckoned from date of issue of work order.
- 6. Site location: Various E/S/S in NDMC area, as directed by Electric Meter Workshop of Commercial Department.
- Taxes: Base price and GST shall be quoted separately, however aggregate payment shall be made by NDMC.
- 8. Defect liability Period: Shall be for the period of 1 year from dated of successful completion of work
